AGREEMENT

- 1)** By the start of the tour it will be the participant's responsibility to ensure that their medical aid would cover any treatment that may be needed whilst on the ride. The organisers will be responsible for emergency evacuation and all costs relating to this would be for the individuals account.
- 2)** The organisers will provide third party insurance for the duration of my participation, covering me in respect of any third party accident, but that any costs associated with the repair of my motorcycle due to rider error or careless riding will be covered by me.
- 3)** I will ride responsibly at all times and accept that I am responsible for my own safety. I am aware that riding motorcycles is dangerous and unpredictable. I understand that any accidents I am involved in are to be resolved by me, my insurance provider and the third party only.
- 4)** I am aware that due to the nature of this event I may be out of reach of medical assistance at various times before, during and after it. I accept that immediate medical assistance may not always be possible and that due to the distances covered each day I may be many hours and miles from hospital. I appreciate that at times medical assistance may be delayed by reason of circumstances such as heavy traffic, attendance at another accident or vehicles breaking down.

- 5)** I do not suffer from any drug or alcohol related dependency. I am aware that it is illegal to ride under the influence of alcohol or drugs and that if caught I could face criminal charges. I acknowledge that if the organisers believe me to be incapable of riding (for any reason) they can remove me from the tour until they decide I am fit to take part.
- 6)** If I make changes to the itinerary before, during or after the tour I alone will be liable for anything resulting there from. This includes going off route where I will be without support of the team members or medics.
- 7)** I accept that the organisers will be within their rights to exclude me from the tour at any time, although full reasons will be given to me should this occur.
- 8)** I will not remove any piece of the bike as a souvenir and will replace (and pay for) any item missing or damaged.
- 9)** I understand that bed, breakfast, lunch, dinner, bike hire, fuel and all airport transfers will be supplied by the organisers but that all other expenses (including drinks, phone calls and gratuities) will be my own responsibility and settled prior to departure.
- 10)** I accept that any damage or breakages caused by me during my stay in hotels or at other accommodation during the tour will be my responsibility.
- 11)** I will heed the advice of the organisers about the riding conditions, including that given to me during the introduction speeches. I will take proper care to ensure my safety and will not put any third party at risk.
- 12)** I am aware that I must bring with me all items marked 'essential' on the KIT LIST and use them at all times when riding on Ride 4 Change.
- 13)** I acknowledge that there are risks involved in any adventure travel activity, including, but not limited to the dangers of travelling in mountainous terrain, high altitude, forces of nature, civil unrest, terrorism, travel by aircraft, truck, bus, jeep, car, motorcycle, bicycle, watercraft or any other means of transportation, accident or illness in remote areas without means for rapid evacuation or medical facilities.

THESE CONDITIONS TOGETHER WITH THE ACKNOWLEDGEMENT WE ASK YOU TO SIGN AND THE GENERAL INFORMATION FOUND IN OUR PUBLICITY MATERIALS FORM THE BASIS OF YOUR CONTRACT WITH TOUCH AFRICA. YOU MUST COMPLY WITH ALL THAT YOU AGREE TO IN THE ACKNOWLEDGEMENT AND THE REST OF THE CONTRACT. WE WILL ACCEPT RESPONSIBILITY FOR THE RALLY AS AN "ORGANISER" PURSUANT TO THE PACKAGE TRAVEL, PACKAGE HOLIDAYS AND PACKAGE TOURS REGULATIONS.

1. REGISTRATION

On receipt of your application and registration fee, we will, subject to the application being in good order, send to you a document confirming your place on the event. You should check it carefully and contact us immediately if any information appears to be incorrect or incomplete. It may not be possible to make changes at a later time.

2. COST

The package cost as per itinerary is £1400. This amount includes Rental of Honda CRF 230 for 7 Days, All Meals & Accommodation, Transfers to and From East London Airport, Competent Guides and Sweeps, Luggage Truck.

3. PAYMENT AND DEPOSIT

50% is required within 14 days of signing and balance is required 30 days prior to start of Tour

4. TRANSFER OF PARTICIPATION

If you are prevented from participating in the Tour, you may be able to transfer your place to someone else introduced by you provided that we are notified not less than four weeks before departure

5. INSURANCE

Adequate travel insurance is essential. You will be responsible for your own travel insurance which must cover off road motorcycle touring for machines up to 250cc. Proof of insurance will be requested. You are not required to provide insurance cover for the motorcycle itself in that third party cover will be provided by us. But should damage occur to your machine through Rider error you will be liable for the cost of repair. It is your responsibility to ensure that the insurance cover you purchase is suitable and adequate for your particular needs.

6. OTHER CHANGES AND CANCELLATION

We reserve the right to make changes to or correct errors in published and other details (before and after registration) and even to cancel confirmed places. If we have to make a significant change, we will tell you as soon as possible and, if there is time to do so before departure, we will offer you the choice of accepting the changed arrangements or cancelling. But compensation will not be payable and no liability will be accepted by us where we are forced to make a change or cancel as a result of unusual and unforeseeable circumstances beyond our control, the consequences of which we could not have avoided even with all due care. Further, no compensation will be payable and the above options will not be available if we cancel as a result of your failure to comply with any requirement of these Conditions entitling us to cancel or if the change made is a minor one. A minor change is any change which, taking account of the information you have given us at the time of registration or which we can fairly be expected to know, we could not reasonably expect to have a significant effect on the trip.

7. FORCE MAJEURE

We will not be liable to you if the performance of our obligations or those of any supplier is prevented or affected by you or if you otherwise suffer any damage or loss as a result of "force majeure", which means any event which we or the supplier of the relevant service(s) could not, even with all due care, foresee or avoid. Such events include war or threat of war, riot, civil strike, actual, threatened or suspected terrorist activity, industrial dispute, natural or nuclear disaster, adverse weather conditions, fire and any similar events outside our control.

8. OUR LIABILITY TO YOU

We will make sure that the arrangements we have agreed to make or provide as part of our contract with you are made or provided with reasonable skill and care. This means that, subject to these Conditions, we will accept responsibility if, for example, the arrangements are deficient as a result of such failure by ourselves, our employees, agents or suppliers. It will be your responsibility to show that reasonable skill and care has not been used if you make a claim against us. Also, we will only be responsible for what our employees, agents and suppliers do or do not do if they were at the relevant time acting within the course of their employment (for employees) or carrying out work we had asked them to do (for agents and suppliers).

For all claims which do not involve death or personal injury, if we are found liable to you on any basis the maximum amount we will have to pay you is the amount paid by you to us in respect of the ride. We will not be responsible for any injury, illness, death, loss (eg loss of enjoyment), damage, expense, cost or other sum or claim of any description whatsoever which results from any act and/or omission of the person affected or the act and/or omission of a third party which were unforeseeable or unavoidable or "force majeure" as defined above. We do not accept responsibility for any services which do not form part of our contract with you, such as additional service or facility which any supplier agrees to provide for you if the service or facilities are not advertised in our publicity materials and we have not specifically agreed to arrange them.

9. COMPLAINTS AND PROBLEMS

If you have any reason to complain or experience any problems, you must immediately inform our representative and the supplier of the relevant service(s). Any verbal notification must be put in writing and given to our representative and the supplier as soon as possible. If you remain dissatisfied, you should contact us at the earliest opportunity. Until we know about a problem or complaint, we or the supplier cannot begin to resolve it. If your complaint or problem is not resolved to your satisfaction you must Write to us within 28 days of your return to your country of residence) giving full details.

10. BEHAVIOUR

You will be responsible for any damage or loss caused by you. Full payment for any such damage or loss must be paid at the time direct to the third party. If you fail to do so, you will be responsible for meeting any claim subsequently made against us (together with our own and the other party's full legal costs) as a result of your acts or omissions. If in our reasonable opinion or in the reasonable opinion of any supplier, you cause or are likely to cause danger, upset or distress to any third party or damage to property, we and/or the supplier concerned are entitled without prior notice, to terminate the arrangements made for you. We will then have no further responsibility towards you including return travel arrangements. No Refunds will be made and we will not pay any expenses or costs incurred as a result of the termination.

11. SPECIAL REQUESTS

If you have any special request, you must advise us in writing when you apply to participate in Ride 4 Change. Although we will endeavor to pass any reasonable requests on to the relevant supplier, we cannot guarantee any request will be met and failure to meet any special request will not be a breach of contract on our part. Confirmation that a special request has been noted or passed on to the supplier or inclusion of the special request in your confirmation or any other documentation is not a promise that the request will be met. We cannot accept any conditional bookings and all bookings will be treated as "standard" bookings subject to these provisions as to special requests.

12. MEDICAL PROBLEMS

If you have any medical problem or disability which may affect you, you must tell us in writing when you apply (or on it arising if later) so that we can advise as to the suitability of the rally. If we or the supplier of the service in question reasonably feel unable to properly accommodate your particular needs, we must reserve the right to decline the application or, if full details are not given at the time of registration, cancel when we become aware of these details.

13. PUBLISHED INFORMATION

The information contained in our publicity materials is correct to the best of our knowledge at the time of publishing. Please note that the published information may have changed by the time you come to book your arrangements. Whilst every effort is made to ensure the accuracy of such information at the time of printing, errors do occasionally occur. You must therefore ensure you check all details with us before you apply. The Weather: The temperature will vary according to where we are during the trip. It is winter and temperatures will very unlikely drop below 10 deg Celcius with the midday temp being approx. 26 deg.

Taking these temperatures into consideration please be sensible when it comes to sunscreen. We have recommended in the kit list that you use a high factor.

The mosquito situation: The current route does not pass through malarial regions,

Water: It is important that you drink plenty of water throughout the day. Water can be bought in any town or village that you pass and will be available to buy each morning. Always check that the seal on the bottle has not been broken. If you stop roadside for lunch please make sure that the water, if not bottled, is safe to drink. We strongly advise that you only drink bottled water from a sealed container.

QUESTIONS AND ANSWERS

Do I need to be reasonably fit? You do not need to start marathon training but it would not hurt to increase your cardiovascular workout. If you are not doing any exercise and have no desire to join a gym then we recommend that you try to walk at a fast pace for a minimum of twenty minutes three or four times a week. For those of you who are members of a gym carry on as usual.

Stamina is important because the combined effects of long, arduous bike rides in intense heat, on badly maintained roads will leave you exhausted. Combine this with early starts, little sleep and new food it becomes clear your body needs as much help as it can get. A small amount of effort prior to departure can make all the difference.

Is there anything I should not bring? We recommend that you do not bring any valuables; this includes all laptops and other electrical equipment. We recommend that you do not bring clothing or footwear that you are worried about ruining. Expensive camera equipment should be insured and well protected.

How much spending money will I need? You will need to bring some spending money with you to buy drinks. Each evening. All hotels do take Visa and MasterCard. However you will not need a great deal. Budget on R2000 for entire trip.

Do you tip? Tipping is discretionary, it is usual to tip porters at a hotel but they should not expect it. Please ask if you are unsure how much to tip. At the end of the challenge we will hold a whip round to collect money for the drivers and mechanics that help us throughout the trip. You will find them invaluable and incredibly helpful.

What should I expect with regards to the accommodation? Think basic and then nothing will shock you. The accommodation we stay in will be hotels of average 3 star and you may be required to share.

Do I need Travel Insurance? Participants MUST be covered by suitable travel insurance and will provide proof of this to us. This must include adequate provision for motorcycle riding on machines up to 250cc, medical and repatriation insurance. A copy of this insurance must be sent School Aid 4 Africa before departure. You are NOT required to cover the motorcycle itself - third party cover is provided by Red Cherry Adventures but if motorcycle damage occurs through rider error you are liable for the cost of repair.

What do we do in the evenings? Once you have settled into the accommodation and had something to eat and drink, you will have the chance to catch up with the other people on the trip, share the trials and tribulations of your day, compare bruises over a beer and fall asleep in front of a huge camp fire. We do awards evening and a slide show each eve.
